During the 16 school weeks, midterm test, classroom, lab or fieldwork practices may be scheduled. Wednesdays can be used for face-to-face activities but there is no previous classroom booking: the scheduled activities will have to be included in the timetable of the file, that will have to be approved by the school supervisor (to avoid overlaps). This is a TENTATIVE timetable and it may change within the course circumstances and with previous notice.

The weeks 18 to 21 will be dedicated to content test (exams or equivalents), that must never be worth more than a 50% of the course. If a test (specially exams) represent a 30% or more of the total grade, the student will be entitled to retake the test. The correction of the exam must be quick in these cases and the signing of transcripts can be delayed beyond the specified date (the vice-chancellorship considers sanctioning the delay regarding the possibility of demanding the recognizing of the teaching activity or other similar initiatives).
