Fundamentally practical subject aimed at knowing the main characteristics of the writings that existed in Western Europe, the spellings, the different types of documents, the dating systems and the writing material. The overall goal for the student will be to be able to read and transcribe documents and inscriptions.

Methodology

An eminently practical subject aimed at learning to read and interpret medieval and modern texts and documents, as an indispensable element for future research.

In this sense, the classes combine the theoretical explanations with the practical application of the same.

Learning will be done, in class, through the use of text dossiers and other teaching materials.

As for the epigraphic texts, in addition to the dossier used in class and the corresponding teaching materials, sessions will be held at the Seu Vella de Lleida and the Museu de Lleida, weather permitting.

The student will have to present a work on original documentation (transcription, paleographic and diplomatic analysis) of a medieval or modern document. This work will require attendance at tutorials with the teacher to follow up during the course.

To complete the assessment, the student will take a final test of reading texts.
