## Subject's extra information

**(The information on this subject has been automatically translated from the Catalan language that will always be the reference guide for any question. Contact the subject coordination for any clarification)**

The Clinical Practices are preclinical practices, in the form of independent clinical rotary and with a final evaluation of competences, in the Primary Care Centers, hospitals and other assistance centers that allow the independent competence development of the nursing students, this progress is progressive and gradual through the different courses.

The subjects linked to the Clinical Practices are mandatory. They are divided into 7 subjects with different credits according to the course, appearing increasingly; that is to say in the first a single subject of 6 ECTS, second a subject of 12, in third two subjects of 12 and in fourth, three subjects, two of 12 ECTS and one of 15. These subjects focus on the attention of the person throughout its life cycle and in the different healthcare contexts: hospital, community, social care, residential and, among others, more specific, such as mental health. Its purpose is the development, in a real context, of nursing care in activities of prevention, promotion, treatment or

accompaniment of healthy or sick people, groups of people or society.

The contents of the practices are related to the course and the expected competence level of the student body.

The first year are aimed at discovering the health context and a first contact with the care context, the second are located in basic hospital units and aim to train in the basic nursing techniques, the third course involve a reinforcement of the practices of the second course on one side and the attention to the pregnant woman, the child and the elderly person is introduced and in the fourth year different itineraries are proposed for the students to know the specialized units and the attention to the community. The teaching methodology has two axes: the preparation activities (theoretical classes, seminars on topics with a clear implication in the attention to the person and practical classes on nursing techniques) and the welfare practices. In the assistance practices, direct attention to the person is collected, collaboration with the care teams, clinical case work in the healthcare center or tutorials, plus personal work associated basically with the preparation of reports or memoirs of practices

The evaluation system consists of three evidences: 1, evaluation of preclinical preparation activities; 2, students' elaboration of the reports or memories of clinical practice, and three, competence assessment of the process in the specific context of the practices by the professional responsible for the student. For the clinical practices, different instruments or rubrics have been developed that allow the competence assessment for a specific signature according to the expected level (see evaluation system).

The teaching center develops the management of clinical practices through the coordinators, who work together with the associate clinical professors. These are teachers-tutors of clinical practice, the function is the direct follow-up of the clinical learning of the students while they serve as a union between the theoretical teaching and the care practice. This professor gathers the optimal conditions for this subject, attending to his specialization assistance, to the technical and theoretical knowledge required and to or great knowledge of the assistance environment.

In this first-year practicum, both the classroom of skills and the clinical practices are carried out so that the student reaches the competences related to the basic care of the person and is a first contact with the world of care.

## **GENERAL SAFETY STANDARDS FOR SKILLS CLASSROOMS**

- To keep the place of accomplishment of the practices clean and orderly.
- The work table should be free of backpacks, folders, coats ...

## **Learning objectives**

The main objective of the second year course is that the student reaches the necessary skills to carry out the basic techniques of nursing.

Its role is to observe and evaluate, diagnose and elaborate a care plan to adapt to the healthy or sick person, by implementing theoretical knowledge, applying it to care, providing the necessary nursing care and Skills acquired in the first and second year class.

### **Learning outcomes:**

- Identify the nursing competence level within the health system, as well as basing the professional performance on the responsibility and functions of nurses, according to professional standards.
- Provide a professional health care according to the manifest needs of the users / patients / families / community.



- Ensure in the practice of care the rights of patients by keeping ethical principles as a priority and according to their beliefs and values.
- Maintain the confidentiality of patient data and professional secrecy.
- Apply the ethical code of the nursing profession.
- Sustain care in scientific evidence and available means.
- Evaluate patients in a systematic and holistic way through a standardized model.
- Actively participate in the healthcare team
- Show initiative and be critical of your own actions and that of other professionals.
- Plan care for patients through the PAE
- Use drugs and products based on nurse prescription
- Perform the nursing procedures according to the characteristics of the context and the specific characteristics of the recipients of the same.
- Administer drugs and other therapies safely.
- Develop the autonomous role and collaboration according to the level of competence required in each situation.
- Demonstrate ability to solve problems and make clinical decisions.
- Elaborate reasoned and evidence-based clinical judgments.
- Promote in the users / patients / community interventions of promotion, prevention and healing according to their health situation.
- Ensure the comfort of all patients, especially care for the most vulnerable by age or health situation (disability, care at the end of life, among others ..)
- Promote the active participation of patients in self-care activities.
- Plan and carry out health education on healthy habits and knowledge that make it easier for users to take care of their own health
- Establish a good relationship and effective communication with patients and family
- Ensure the correct use of facilities and materials
- Prevent situations of risk and act accordingly avoiding the harm of patients, family members, partners and their own.

## Competences

### **Clinical practices:**

The student, to be able to do the practices, must obtain a qualification of apt in the classrooms of skills, in this way demonstrates that he has learned and assimilated the knowledge and skills of the basic procedures and the cares to be able to carry them out in the clinical practices

In this course, each student will complete 2 internship periods that are divided into the following services or units:

- Hospitalization Units

### **Periods:**

According to the academic calendar

## Methodology

For the correct development of the subject the following teaching methodologies will be carried out:

- Master classes.
- Seminars
- Individual work.

- Practical classes: demonstration room and / or simulation.
- Assistance practices.

Given the uncertain situation that the social distancing measures established by the health authorities do not allow the development of some teaching activity in the classroom for all enrolled students, a mixed teaching modality will be adopted that combines this classroom teaching with distance teaching. In the same way, tutoring may be replaced by remote tutoring using telematic means.

## **ABSENCE JUSTIFICATION OF THEORETICAL-PRACTICAL SUBJECTS**

In relation to the justification of absences, the reasons for which the absence is considered to be justified will be the same as those set out in point 3.1 of the Regulations for the assessment and qualification of teaching in the degrees and masters at the UdL for not attending the assessment tests or practical scheduled in the teaching guide or on the website of the degree.

For other situations arising from health, personal or family problems, students will be allowed to change the day and make up the seminar/practice during the week, if possible, and always within the period, bearing in mind that it is not possible to double up in all those services that offer another type of recovery.

Requests for justification of absences that involve failure to attend an assessment test or day of practice must be submitted on the same day of the absence. The justification for other absences must be presented at the latest within the following 10 days.

In general, students will only be excused for absence, but not for failure to fulfil their academic commitments.

All changes or recoveries will have to be accepted by the unit tutor, the subject coordinator and registered in the virtual campus before the practice is carried out.

Failure to comply with these requirements may be considered a serious offence that may lead to the suspension of the internship period.

## **Development plan**

### **Training activities**

#### **Seminars and Skill Classrooms**

The theoretical-practical seminars will be carried out depending on the calendar drawn up for this purpose and that will be made known to the students at the beginning of the course.

Practical activities / classrooms is a type of training where, through the immersive simulation methodology, the student practices, prior to going to the healthcare services, the skills necessary to develop skills to care for healthy and sick people.

All classes in the classroom of skills are compulsory and the student will not be able to initiate the clinical practices without having reached the minimum level in each one of the classrooms.

The Practicum coordinators will establish the forms of recuperation, in the event that the student has not been able to take a class for justified reasons.

Changes are allowed with justification and 1 to 1 with another student of the same service and prior authorization of the coordination of the subject, otherwise it will be considered a serious offense.

### **The period of internships**

Clinical Practices: Once the student has passed the theoretical and pre-clinical part, they will do the programmed practices that will last 8 hours a day, in the morning from 7:30 to 15:30, and in the afternoon from 14:30 to 22 : 30 or night if applicable. In cases of centers or services with different schedules, the student must adapt to the center's schedule, always ensuring the minimum duration of 8 hours per day). The students will be governed by the festive calendar of the town in question. This organization can only be changed for justified reasons (medical or academic) and with prior authorization from the coordinator and registration at least 48 hours in advance.

Clinical practical credits are carried out through a student-centered learning methodology, leading this one to their

own learning, and giving them the opportunity to acquire the necessary skills to develop a practice Optimal professional, while encouraging his reflection and self-criticism

It should be taken into account that the student will always be accompanied by a professional nurse in all the healthcare activities required by the patient (care, controls, preparation and administration of medication, techniques, information, education, etc.) or by delegation accompanied by a nursing assistant in tasks such as hygiene and patient bed; activities that the student will perform with a professional nurse or accompanied by a nursing assistant. The assignment will be made by the coordination of the subject and following the mobility guidelines and assignment of places of practices of the FIF.

Students must follow the regulations of the internship center and the UDL in relation to COVID19 or other possible outbreaks of communicable diseases.

## Diary of internships

Written work where the student compiles different documents and evidences that he elaborates during the clinical practices, in order to demonstrate his path and development of competences (ex: thoughtful newspaper, development of an issue of interest, assessment of a patient's nurse )

## Evaluation

### FIRST EVALUATION EVALUATION: Note of the classrooms of abilities (15%)

The attitude and the aptitude will be taken into account as well as the note of the evaluation test that will be carried out in each subject through the corresponding heading. You must pass this section with a minimum of 5 marks.

• 50% Exam (before classrooms A, B, C, D, E and F):

- or 10 test questions
- or A "10" means 0.25 points more in the final note of the A / H, a suspense 0.5 points less.

• 50% attitude and aptitude to Aula de habilidades

• Absence in the theoretical or practical classes supposes a penalty of 0.5, by absence, to the final note of the A / H.

### SECOND AND THIRD EVALUATION EVALUATION: Note of the clinical practices (85% BETWEEN THE TWO)

The attitudes and abilities of the student will be evaluated by observing and using a specific heading:

• Average of the final mark of the periods (80% of the note is the healthcare part and the remaining 20% the is the reflective diary)

The attendance to practices is mandatory and therefore ALL ABSENCES ARE RECOVERABLE AND TO BE JUSTIFIED, it is essential to complete 100% of the scheduled hours and to comply with the regulations of practices established by the University.

There is the possibility of doing a voluntary internship period in the clinical analysis service that may slightly modify the final grade for the course.

Any evidence that has a plagiarism percentage higher than 50% or that is submitted after the deadline will not be corrected and will be graded directly with a 0. Evidence between 20% and 49% plagiarism will be analyzed individually.

**If a student does not remove a 5 practice note in any period, he will not do the job and the whole period will be suspended.**

**The student must approve each of the parts of the assessment separately and practice periods in order to be able to ponder and pass the subject.**

**Qualification: The maximum qualification of the subject is Honors.**

**Mobility: Mobility is not accepted in this subject.**

**Unique evaluation: This course does not have a unique evaluation option.**
