In this context, and in order to unify the criteria and procedures that guarantee a homogeneous performance in the planning and evaluation of the TFG of the degrees that are taught in the Faculty of Nursing and Physiotherapy of the UdL, it is advisable to establish guidelines specific to the definition, execution, defense, qualification and administrative processing of these works in accordance with the general regulations of the UdL.

GENERALITIES

- The TFG has a teaching load of 9 ECTS credits.
- It is an individual work carried out under the supervision of a tutor.
- It must be done in the final phase of the study plan (last year).
- Its purpose is to assess the skills associated with the degree in Nursing.
- It is a prerequisite for evaluation to have passed all the subjects. In this way, students who do not pass the pending compulsory and basic subjects will not be able to be evaluated for the TFG and the corresponding grade will be recorded as "not presented".
- There are no enrollment requirements. Students will be able to present the written work of the TFG on the established date. However, it is a requirement for the reading and defense of the TFG to have passed all the subjects of the degree. In the case of double degrees, the requirement corresponds to having passed the subjects of the degree in Nursing. Therefore, if all the subjects of the degree have not been passed, the TFG cannot be defended and the corresponding record will contain the qualification of not presented. You can enroll again the following academic year.
- Those students who are unable to present themselves to the June call, may do so in the extraordinary September call.

Subject contents

The TFG consists of carrying out an original study, in which the received training contents, academic and professional competences acquired during the training period of the Degree are integrated and developed. It aims to train for the research, management, organization and interpretation of information, to make judgments that include a reflection on relevant issues of a social, scientific, technological or ethical nature and facilitate the development of critical and creative thinking and judgment. Types of TFG It is recommended that the TFG correspond to one of these typologies or topics (see the Methodological Guide according to the typologies of TFG):

- Systematic review of the literature.
- Methodology and nursing perspective.
- Health education program.
- Research project, which may include the development of an intervention.
- Healthcare innovation.

Methodology

Face-to-face sessions

Face-to-face sessions include:

- Information session: in this group session you will be informed about the subject and it will be taught by the coordinator of the subject.
- Individual sessions: correspond to individual or group tutorials with the tutor. In these sessions, the written work and the oral presentation will be guided and monitored. Tutorials may be face-to-face at a distance.
- Presentation and oral defense of the work described in the Evaluation section.

Self-employment

The remaining time will correspond to the autonomous work of the student, following this guide and the guidelines set by the tutor.

NOTE: Application of the Data Protection Act.

Tutorials can be recorded, for this reason the University of Lleida informs that, for teaching purposes, it will record images that identify students and other people who participate in academic activities. The person responsible for the processing of these images is the University of Lleida (contact details of the representative: General Secretariat. These images are only used for teaching, assessing knowledge of the subject and for teaching improvement projects. Development plan

PHASES OF THE TFG

- Elaboration of the TFG

During this phase, the student will develop the work through the supervision of the tutor. Depending on the type of work, the sections will be those described in the Methodological Guide Document according to the typologies of TFG. The final delivery of the work will be made through the virtual platform, where an 'Activity' will be opened for this purpose. The deadline for submission to the June call will be in May (date to be confirmed). If it is not complied with, the work will automatically be as Not Filed, and cannot be defended in court. In its formal aspect, this work must conform to the Guide of presentation of written works of the Faculty of Nursing and Physiotherapy of the UdL available in the page web of the Faculty (http://www.fif.udl.cat/export/sites/Fif/ca/.galleries/Documents/Guia_presentacio_treballs_escrits_v1.0.pdf). The text of the work, including only "the development or body of the work", will have a maximum length of 30 folios.

- Presentation and defense of the TFG

The student must present and defend the work before a court. The exhibition will be oral with multimedia support. The oral presentation will last a maximum of 10 minutes. The defense will then take place and during it the speaker will answer the questions, suggestions or clarifications posed by the members of the court. Finally, the court will deliberate and agree on the note that will be communicated to the person. For their innovation, originality and quality, all those works that obtain a grade higher than 9 will be candidates to be published in the 'Contact of Catalonia (RECERCAT)' and in the 'Open Repository of the UdL'. To do this, both the student and the tutor must sign the relevant authorization. It is recommended that on the day of the presentation the student be presented in appropriate attire and in accordance with the occasion. That is, clothing that is appropriate for the exhibition, as the presentation and defense session is a formal academic event. The courts are public in nature, so family, friends or anyone interested may be present as a spectator during the presentations.

Evaluation

The evaluation will consist of:

- The evaluation of the written work, which corresponds to **60% of the final grade**
 - **Monitoring and progress of the written work: 30%**. The tutor will evaluate the follow-up and progress prior to the delivery date of the final report. The aim of the same is to value a series of

generic and specific competences acquired from the autonomous work of the student and of continuous form. They will be evaluated using the process evaluation guideline.

- **Final report: 30%.** The tutor will evaluate the final result of the work in all its aspects according to the guideline of evaluation of the final result of the TFG according to the typologies or subjects.

The evaluation of the **oral presentation and defense of the TFG, which corresponds to 40% of the final grade**

The court will evaluate different aspects during the oral presentation and the defense, following the guideline of evaluation of the exhibition and defense of the TFG. To participate in the presentation and defense phase, a positive evaluation will be required in the Written Work. The oral presentation and defense of the TFG will be held before a panel of three professors of the Degree in Nursing. The TFG is approved with a minimum grade of 5 out of 10, being the result of the sum obtained between the evaluation of the written work and the oral presentation and defense of the TFG, respecting the corresponding percentage. It is essential that both parties are approved to pass the whole course. For the assignment of honors enrollments (MH), those students will be considered the final grade is equal to or higher than 9 and have been chosen by the court as candidates for obtaining this Enrollment.

An ad hoc commission will be convened, which will evaluate the written work, in accordance with the evaluation rubric and assign the corresponding MH number among the candidates presented. Committee members will not be the tutors of the students involved in the procedure.

Students who apply for the October special call will not be eligible for the honors registration.

Extraordinary call for September

The September special call is for those students who, not being able to apply in June and follow the schedule for this call as indicated in the PROGRAMMING section.

Evaluation of students participating in **mobility programs (OUTCOMING) Students** who carry out part of their studies at another university during the fourth year of the degree and their stay is longer than 4 months, will carry out the TFG at the destination university, provided that the UdL agreement with the destination university so provides. allow. If you do not allow it, they will do it at the UdL for which mechanisms will be established for an online tutorial follow-up. In the event that it is carried out at the destination university, if the teaching load of the TFG is less than 9 ECTS, the committee will review the work submitted and assess whether it meets the validation requirements or, conversely, it must be supplemented.
