Methodology

Big group activities:

Classes are held weekly in three-hour sessions. The format is the master class, encouraging student participation.

Medium groups activities:

Classes are held weekly in one-hour sessions. In these classes will be: watching movies; legal practices and essays, case studies, debates and collective tutorials. In these classes students will have to do exercises, comments on texts, laws and sentences and various activities related to the contents of the subject.

The activities will be based on work materials provided by the teacher. The dynamics of these classes help to follow and clarify the contents of the subject. It is sought that the student in addition to learning and knowing a certain information knows how to access the subject and obtain the information for the study of the subject, creating channels to access the knowledge, to form a critical spirit towards the rules and court cases, learn to reason and question this determined in laws, rules and legal discourses.

Evaluation

A) Continuous evaluation:

It is the normal evaluation system. The final grade will be based on the partial grades obtained in two multiple choice tests and two practicals. The grade of "not presented" will be applied as long as the student has carried out a percentage of less than 30% of the evaluation activities of the subject. In the event that 30% or more of the evaluation activities have been carried out, the corresponding qualification will be entered in the minutes (agreement of the Faculty degree and master's degree commission of January 27, 2021).

1. Multiple choice exams:

Throughout the course there will be two multiple choice tests, on the topics of the lessons of the teaching plan.

First Test: see previous section

Rating weight: 25%

Second Test: see academic calendar.

Rating weight: 25%

The exams will consist of 20 questions with 4 answer options and only one correct one. Each correct question scores 0.5 points. Each wrong answer subtracts 0.15. The time for its completion is 60 minutes.

2. Practices:

Throughout the course in the middle groups there will be 2 reading and commenting activities on legal texts.

The weight in the qualification of that of each of the practices 25%. In the face-to-face classes and the virtual campus you will find all the information necessary for its completion as well as for the correction of the practices by the students themselves.

B) Single evaluation:

According to the regulations of the FEPTS. In this case, there will be a single multiple choice test on the subject matter.
