Subject's extra information

Study of the incidence of social factors on the diversity of linguistic behavior and on the structure and evolution of the Spanish language, paying special attention to the contact of Spanish with other languages and its linguistic regulation and planning, as well as the impact of gender differences and their contribution to the construction and maintenance of sexual stereotypes, designing alternative strategies.

Comments: It is informed that any exercise that has more than five spelling or construction errors will be automatically suspended, in the understanding that the presence of spelling, punctuation, morphological and / or drafting errors will always be taken into account in the time to evaluate the subject. In subjects of a Philology degree it is essential to use the language (oral and written) with correctness and rigor.

Foreign students who come from mobility or exchange programs must bear in mind that this subject requires an oral and written knowledge of the Spanish language corresponding to an intermediate level (B2 of the Common European Framework).

Learning objectives

- O.1. Acquire the basic notions and methods of sociolinguistics, the sociology of language, the ethnography of communication and ethnolinguistics.
- O.2. Recognize the repercussion of social factors on linguistic behavior and grasp that languages are not aseptic but contain a particular and biased view of the world.
- O.3. Identify the sources of gender inequalities that operate in the linguistic system and in the communication and design of strategies to promote equity.
- O.4. Discover the different mechanisms of linguistic change and analyze the situations derived from the contact of Spanish with other languages in Spain and in America.
- O.5. Develop basic skills that allow an approach to linguistic policy and planning mechanisms.
- O.6. Put into practice the methods of quantitative and qualitative analysis of the social sciences.

Evaluation

In subjects of a Philology degree it is essential to use the language (oral and written) with correctness and rigor.
2. If academic fraud or spontaneous copying is detected, we will apply what is established in the *Regulations for the Assessment and Grading of Student Learning in UDL Bachelor's and Master's Degrees*.
3. It is a requirement to have passed the work and get an average of 5 between both exams to apply the percentages.
