## Subject's extra information

This course looks at the physical, human, historical, economic and cultural characteristics that constitute modern Europe. It delves into the complexities of the idea of Europe stemming from the focus of Physical and Human Geography. Regardless of where you draw the boundaries of the European area, or how you consider the "continent" or the political union that brings together a significant number of countries, the geographical concept of Europe is highly determined by its "content"; thus Europe is a social reality that can be studied as a whole.

Through the regional study of Europe, the student will delve into the geographic and socioeconomic factors that have shaped the European territory during the 20th and 21st centuries, as well as the political organization, functioning and construction of the European Union, a supranational entity very present in the functioning of European society.

- Critically analyze some of the main environmental, political and social issues in Europe.
- Apply concepts and methodologies from Physical and Human Geography to study patterns of change in Europe.

### Development plan

It is a core subject of the Geography degree. In this subject, the students will acquirebasic knowledge in the theoretical part that will be essential to understand the complexity of the European space today, from both physical, human, historical, economic and cultural point of view.

This course consists in a theorical component, which will be complemented by different methodologies, in which the basic concepts acquired are essential to carry out the practical exercises in the classroom autonomously, with the help of the documentation provided and the possibility of solving your doubts with the teacher in the classroom or in specific tutorials. In addition, the course includes at least one field trip that will help students to assimilate the knowledge acquired in the classroom, and will also provide information for other tasks.

#### **Evaluation**

#### Practice block (30%)

#### Other considerations
