## Subject's extra information

Urban Geography focuses on the study of urbanization processes and the analysis of the context that explains how, when and why. cities and the urban world change and transform (or not). The etymology of CITY (civitas) refers us to a particular socioeconomic and political organization. While the terms URBAN / URBANIZATION (Urbs) refer to the urban factory (the physical and functional construct) and to the process of physical and functional transformation of the space that also entails changes in the ways of life. These forms of urban life increasingly characterize our societies and those of those territories most articulated in the processes of contemporary globalization. Globalization has become the main engine and diffuser of the urban, contributing to the dissolution of the already widespread barriers between the rural and the urban, the city and the countryside. An urbanization process that has also been fueled in recent decades by the processes of financierization of the economy.

Despite the contrasting and often contrasting views (filias and phobias) on the urban and the cities, it is undeniable that the city is one of the most complex artifacts that humanity has ever created and that the process of urbanization has been one of the most intense and spectacular transformations of contemporary societies.

The aim of the course is to offer a complete and transdisciplinary introduction to the urban phenomenon, addressing the current dimension and historical genesis from the industrial revolution to the problems of urbanization and its main result: the city. The aim is for the student to know the main theories and concepts in the study of the urban and to know how to use the main sources and instruments necessary for the analysis of the contemporary city in the European context.

There are very different ways of approaching the study of urbanization and cities that Urban Geography has tended to focus on:

- the study of networks and interurban relations;
- the study of form, functions and social composition;
- the study of historical processes and urbanization contexts.

Addressing all possible approaches (which are not exclusive) would go beyond the framework of a single subject, so it is decided here to focus on the second and third approaches. In fact, in the framework of this subject we are interested in the historical study of urbanization processes to understand and explain how, when and why growing (or not), cities change and transform and what we consider is urban, in the less since industrialization.

We understand the city as one of the possible results of the urbanization process and, for this reason, it is much more interesting to understand and get to explain the factors that explain it than to look at its results. The theoretical framework focuses on understanding urbanization as a process (the resulting forms and the acting agents) to understand the structures, forms and landscapes and the problems it generates. It is intended that the student knows the main concepts and theories in urban study and knows how to use the main sources and tools needed for the analysis of the contemporary city. At the same time, the program provides basic knowledge on urban planning in the Catalan context.

The course combines three types of sessions. The first type of sessions combines the most theoretical face-to-face classes with the most active participation of students. The second type of sessions are more practical, aimed at knowing and processing data and information sources on urbanization processes and the urban phenomenon at the level of the city as a whole and neighborhoods / districts. The third type of session consists of fieldwork visits to various neighborhoods in the city of Lleida
