The course on regional planning appears to be a compendium of the courses that take part in the field of interest of Geography, though in this case are taken into an applied point of view. Therefore, the contents of the course on regional planning will comprise:

- General basis of the Regional Planning and the models of territorial development.
- Methodologies on territorial planning: analysis, diagnosis and suggestions.
- Methodologies and tools for the sectorial planning with territorial impact.
- Study and evaluation of the natural and cultural resources, the landscape, the human activity on the territory, the environmental problems and the natural risks.
- Tools of planning and territorial development.

## Learning objectives

O1. Initiation to the techniques, regulations, institutional practices and documentary basis used in the regional planning and the specific practice of territorial planning.

O2. Comprehension of the physical, economic and social aspects that characterise the territory, with special emphasis on the interrelations and noteworthy traits, from the knowledge and familiarization with the indicators, analysis techniques and work methodology of the territorial planning.

O3. Analyse and interpret the proposed texts about the country's geography.
