## Methodology

In this subject, lectures will be combined with practical sessions. In the practical sessions, the students will be asked to participate actively in tasks focused on the analysis of the texts that will be dealt with during the classes. In addition, several discussions lead by the lecturer will be carried out with the aim of helping the students establish a dialogue between their previous knowledge and the contents dealt with in the lectures and, also, with the selected texts analysed in class.
