The subject on the Spanish and World Economy is a course that is given for the ADE degree in order to understand and analyse how the international economy and the Spanish economy are structured. The subject is given in the first semester of the third year of the degree course. This allocation relates to a transversal planning of the learning process, which starts in the second half of the first year when the student is given the basics of economics with the Economics I course. It continues in the first semester of the second year with the study of Economics II, in which the knowledge of the macroeconomic field is consolidated and expanded in order to understand the information on the economic reality. In the second semester of the second year, the student is taught and gets to know the measures of the different aspects of economic policy, the aims that these pursue and their impact on the economic agents and sectors, which are the learning objectives of the course on Economic Policy. Moreover, the student has already been given different instrumental tools in the courses on mathematics (first year) and statistics (first and second years). All these learn processes are essential in order to understand today's economic environment and its evolution in the past few decades, knowledge that will be entered into in greater depth in the course on the Spanish and the World Economy.
