Learning objectives

The aim of the course is to provide a general overview of the relations between the Catalan language and the societies that speak it, addressing problematic aspects, dilemmas and specific issues that have been the focus of sociolinguistic research. In addition, the aim is to provide a notion of the research instruments of sociolinguistics and for the student to become familiar with the terminology of the field of sociolinguistics. Finally, the student will be able to critically read and reflect about studies and documents related to Catalan sociolinguistics.

Methodology

Teaching methodology: Face-to-face classes and autonomous work

A) Face-to-face classes in the classroom: 60h

Lectures: Presentation of the contents of the subject orally by the teacher.

Directed debate: Promote oral expression and comprehension in a group conversation in which the topic can be prepared, but not the development of the interventions.

Collaborative activity: A learning activity that must be done through collaboration between members of a group.

Written (individual or group) work: Activity consisting of the presentation of a written document.

Case study or document analysis: Method used to study an individual, an institution, a document, etc. in a contextual and detailed way.

B) Autonomous work: 90h

Autonomous work by students (practices, exercises, readings or study of other materials, questionnaires, etc.)
