#### Methodology

The methodology used will be different depending on the point of the topic that will need to be deepened:

In the first block, the explanatory presentations by the teacher will be combined with reading of texts and research by the student. There will be individual activities on the texts read, group discussions, oral presentations and analysis of case studies.

In the second block, the student will be provided with the contents by the teacher, video views and will link the theory with practice through guest lecturers, attendance at academic conferences and other activities that link theory and practice.

In the last point, and after the explanatory presentation by the teacher of the different techniques, the student will analyze everyday social work situations in order to put into practice the knowledge acquired. In this block there will also be individual and group activities, ending with an oral presentation where the student will demonstrate the concepts acquired.

The explanatory presentations and the different dynamics that take place in the classroom will be modified in order to capture the student's attention and to encourage them to feel part of their own educational process. All the theoretical material used by the teacher, as well as other documents will be posted on the Udl's virtual campus.
