Methodology

Training activities in Large group

Classes will take place every week in three-hour sessions. For the acquisition of knowledge and skills during these classes, master classes, revision of manuals and work dynamics will be used to facilitate the understanding and assimilation of the theoretical contents.

Training activities in Medium groups

Classes will take place every week in one hour sessions. In these classes there will be: text commentary seminars; watching movies; legal practices and case studies, debates and group tutorials. In these classes students must do exercises, comment on texts, laws and sentences and various activities related to the contents of the subject.

The activities will be carried out from work materials provided by the teacher. The dynamics of these classes help to follow and clarify the contents of the subject. It is intended that the student, more than learning and knowing certain information, knows how to access the subject, obtain the information and those necessary for the study of the subject, creating channels to access knowledge, and form a critical spirit towards the norms. and court cases, learn to reason and question this determined in laws, regulations and legal discourses.

Evaluation

The final grade will be based on the partial grades obtained in the two continuous assessment written tests (25% + 25%) and the final grade of the activities carried out in the classes of the middle groups (20% + 20% + 10%)

1. Written tests of continuous evaluation

Throughout the course there will be two continuous assessment tests, on the topics of the teaching plan lessons.

First Test: see previous section

Topics: All the GG and GM topics performed up to the previous week. 25%

Second Test: see previous section

Topics: All the GG and GM topics performed up to the previous week. 25%

These tests will assess the ability to apply the knowledge acquired in class sessions in GG and GM.

The final mark of the tests of the continuous evaluation will be the average mark obtained in the two tests

2. Evaluation of the activities carried out in the middle groups.

Throughout the course in the medium groups there will be between 2 activities for reading and commenting on legal texts (20% of the final grade each) and an essay (10% of the final grade each).

In all the activities the preparation and study of the works, comprehension of films, the reading of the texts, the exposition and the participation in the classes and the works presented in each one of the activities will be valued.

The global value of these activities is 50%

3. Not presented: students who take all the assessment tests but do not reach the minimum grade of 5 will have a Failure grade. Only those who do not appear in any of the tests or do not carry out the continuous evaluation of the middle groups will be classified as not presented.

4. Unique evaluation;

In the event that a student documentary proof of inability to attend the activities scheduled within the Continuous Assessment (for paid work, second or subsequent enrollment of the subject, reconciliation of work and family life

and mobility stays) may choose to 1 final test of validation of competences and knowledge that will take place the second week of exams.
