- To know the difference between reform and destruction of the Constitution and identify the limits to the reform.
- To analyze the structure of the central State, the composition and functions of the organs of the central power.
- To understand the role of constitutional justice, the composition and functions of the Spanish Constitutional Court.
- To know the system of sources of the Spanish legal system.
- To understand the Spanish Constitution in the legal-political framework of the European Union.

The elements of the State: territory and population. Power of the State. Sovereignty and its current crisis. Special reference to the European integration process. **Topic 2:** The historical formation of democratic thought. The contractarian thinking. Democracy and Liberalism. The principles of the bourgeois State of Law as a Constitutional State. Fundamental Rights and Division of powers. The historical crisis of the liberal State. The tension between the liberal State of Law and the social State of Law. **Topic 3:** The constitutional, democratic and social state. Constitution and Globalization. **Topic 4:** The Constitution of the State. Formation of the modern idea of Constitution. The constituent power and the birth of the Constitution. Classification of the Constitutions. **Topic 5:** The transition to Democracy and the Spanish constituent process. The political meaning and the consequences of the constitutional consensus. The political formula of the Spanish Constitution and the basic principles of ordering. **Topic 6:** Supremacy and Rigidity. Constitutional The American and European traditions. The constitutional rigidity. Flexibility and rigidity at present. **Topic 7:** Political change and Constitutional dynamics. The reform of the Constitution: classes, procedures and limits. The non-formal amendments to the Constitution. Constitutional mutations as a consequence of European integration. The reform of the Constitution in the Spanish legal system. The functions of the reform. Classes of reform in the Spanish Constitution. Different reform procedures and their problems: initiative, elaboration, examination and final adoption of the reform. The time limit to the initiative and the controversial absence of limits to the reform. The limits of the reform in our constitutional system.

The meaning of bicameralism in the Spanish constitutional order. **Topic 11:** Bodies of the Chambers: The President, the Bureau, the Board of Spokesmen, the parliamentary groups, the Parliamentary Production Bodies: The Commissions and the plenary. The historical and current meaning of the Permanent Deputation. **Topic 12:** The functions of the Parliament. Legislative function Economic Functions The functions of political control. The interpellations and questions. Proposals not of law and motions. The motion of censure. The functions of political orientation in the Spanish constitutional order. **Topic 13:** The Head of State. The constitutional configuration of the Crown. The functions of the King. The responsibility of the King. **Topic 14:** The Government. Its constitutional regulation. Organization and structure of the Government. Special reference to the President of the Government. The functions of the Government. The regulatory power of the Government. The Government and Foreign Policy. Government and European Institutions. The political responsibility of the Government. **Topic 15:** The Judicial Power: The constitutional principles in this matter. Judicial independence The judicial unit. The submission of the judge to the law. The Spanish judicial organization with special reference to the General Council of the Judiciary. **Topic 16:** Constitutional Justice and Constitutional Court. The budgets of the Constitutional Justice. Characterization of the Constitutional Court: constitutional, jurisdictional, independent and federal body. Composition, internal structure and operation. **Topic 17:** Functions of the Constitutional Court. The defense of the Constitution from the legal point of view. The control of constitutionality: the appeal of unconstitutionality and the question of unconstitutionality. The remedy of amparo (remission). Conflicts between organs. Conflicts of competences.

**C) THE SOURCES OF LAW:** **Topic 18:** The Constitution and the System of Sources of Law. The Constitution as

Legal Standard. The Constitution as a source of legal sources. The Constitution as a source of Law. **Topic 19:** The international position of the State and the constitutional system of sources. The International Treaties. The Law of the European Union. Constitution and European Law. The European Union as a modern form of Confederation. Relations between EU law and domestic law. **Topic 20:** The Statutes of Autonomy. Legal nature. The Statute of Autonomy as Constitutional Law material. Content of the Statutes (special reference to the declarations of rights, duties and principles). The statutory reform. **Topic 21:** The Law. Formal and material concept of Law. Plurality of type of laws in the Spanish constitutional order. Decrees with force of Law: the Legislative Decree and the Decree-Law. **Topic 22:** The Regulation. The Parliamentary Regulation.

## Methodology

Every week will be taught 3 hours of master class and 1 practical class.

Master classes will consist of the presentation, by the Professor, of the corresponding topics according to the weekly schedule. The practical class in the analysis and debate about a text that will be available in advance in the virtual campus and that the student must have read in advance.

It is estimated that the student must complete 1.5 hours of autonomous work for each class hour.

## Evaluation

### A) Continuous evaluation.
