First, because in an increasingly interdependent and global international society, Public International Law allows for analysis of its regulation, and of the projection and conduct abroad of the State and of other subjects and agents who interact in today's international society and who define it as it currently is. Second, because the education-learning process in Public International Law is axiologically based and therefore encourages a reflective and critical approach to the values that exemplify the principles and rules of the international legal system and of how they are applied.

# Methodology

## 2023-2024 ACADEMIC YEAR

- 1. Theoretical sessions. Usually taught in the Theory Group (GG). In them, the content of the subject structured into different topics is developed, trying to clarify the main concepts, guiding students in their learning process and offering complementary bibliography.
- 2. Practical sessions Carried out in the PraAula Group (PraAula) their objective is, on the one hand, to help students exercise and learn to apply theoretical content to particular situations. On the other hand, in relation to some topics that are part of the content of the subject, the reverse method will be used, that is, from the activities proposed and carried out in the practical sessions, the theoretical framework will be deduced. Within the framework of the practical classes, various methodological strategies will be used that will be worked on individually but also, on occasions, through teamwork. They will basically consist of the following: case study, jurisprudence analysis, debate on recommended readings.
- 3. Complementary activities The previous evaluation activities may be complemented with assistance to other activities dedicated to topics related to the content of the subject; such as: conferences, seminars, Classrooms Against Poverty Program or the Cinema and Human Rights Cycle or talks in the classroom space, among others. At the appropriate time, the class will be informed of them.
