#### A.- CONTINUOUS ASSESSMENT CRITERIA

The competences developed by the student will be evaluated through three blocks of qualifications where the acquisition of sufficient knowledge to pass the subject is demonstrated, as well as the capacity for analysis, synthesis, written and oral communication, and critical reasoning.

It will be considered a No Present when the student does not carry out any of the evaluation activities.

#### • BLOCK 1 FROM SUBJECT 1 TO 12: 40%

• Written test of theoretical content. The student will have to pass the block for the percentage to be taken into account in the final grade.

#### • BLOCK 2 FROM SUBJECT 13 TO 26: 40%

• Written test of theoretical content. The student will have to pass the block for the percentage to be taken into account in the final grade.

#### • BLOCK 3: 20%

• The activities programmed in the PraAula group will be evaluated in a practical exam at the end of the semester. To qualify for the percentage of the grade reserved for Block 3, the student must pass each of the theoretical content tests with a minimum grade of 5/10. There will be no arithmetic mean between the two tests.

In the written tests, the student will have to demonstrate knowledge, ability to analyze basic concepts of European Union Law, as well as the ability to analyze and synthesize, written communication and critical reasoning. In the written tests it will not be possible to use the syllabus of the subject.

#### **B.- ALTERNATIVE ASSESSMENT**

In the event that a student provides documentary evidence of their inability to attend the activities scheduled in the continuous assessment, they may opt for a single competency and knowledge validation test that will be carried out on the day and at the time established in the assessment calendar. of the Degree for the final test of the ordinary evaluation with all the matter. The request for this evaluation modality must be made in accordance with the UdL Evaluation Regulations until March 20, 2024.
