**UNIT 3. - The execution of the prison sentence (II).** Prison system. Prisons. Legal status of internal: rights and responsibilities. The disciplinary in prison. Security measures and surveillance

**UNIT 4. - The execution of the prison sentence (III)** Treatment and prison release. The system of individualization science. Relation between classification and regime. Revising sentences and accumulation law. The third degree and prison serving his prison sentence in semi. Probation. Final settlement of condemnation and licensing.

**UNIT 5. - Judicial review of the implementation of prisons.** Judge surveillance prisons. Powers and specific functions. Appeals against decisions of the judges surveillance.

**UNIT 6. - Implementation of alternative measures to prison and other penalties.** The problem of short prison sentences. Aspects of political-criminal and future prospects. Substitute forms of execution of custodial sentences.

**UNIT 7. - Implementation of Security measures.** Classes and content of the measures. Sentences and imprisonment. Execution in case of concurrent sentences and measures: vicarial system.
