The Works in Benefit of the Community. Permanent location Forms that are substitutes for the execution of prison sentences: special reference

to the suspension of penalties.

UNIT 7. - PENITENTIAL TREATMENT AND EXCERCERATION. The system of scientific individualization. Specific treatment programs. Relationship between classification and regime. Refusal of convictions and legal accumulation. The third degree of penitentiary and the fulfillment of the death penalty. Conditional freedom. Settlement of final conviction and licensing.

UNIT 8. - JURISDICTIONAL CONTROL OF THE PENITENTIAL EXECUTION. The prison vigilance judge. Attributions and specific functions. Resources against the decisions of the monitoring judges.

UNIT 9. - EXECUTION OF SAFETY MEASURES. Classes and content of the measures. Privative and non-custodial sentences of freedom. Execution in case of concurrence of penalties and measures: the vicarial system.
