The activity will be attended through the external tutor of the diverse Entities, how for example, Illustrate it School of Advocacia, the Department of company and Employment, Inspection of Work, Registry of the Property, Cabinet Jurídico of the Generality, State Agency Tributària, Bodies and Strengths of the Security of the State, Subdelegació of the Government in Lleida, Institutions Penitenciàries, Provincial Audience, Courts and Fiscalia.
- In the second cycle the student will realise practical continued in the judicial offices assigned through the collaboration of the Centre of Judicial Studies of the Generality, under the address of an external tutor (Magistrate, Fiscal, or judicial Secretary).
