Methodology

ACADEMIC YEAR 2023-2024

The methodology of the subject is based mainly on a high practical component, seeking transversality in knowledge as well as complementarity, taking into account the efficiency of the resources available at the university. Therefore, it will present three different parts:

In the first place, the fundamental theoretical knowledge to understand the different aspects of the subjects will be carried out through master classes. However, this does not mean that the student is oblivious, but rather that they will have to participate actively in the weekly preparation of them by reading the recommended bibliography.

Secondly, as it is a *semipresencial* subject, practices, papers and presentations will be developed. These have as their objective the application of theoretical knowledge to particular situations. Likewise, they will have to write legally reasoned opinions using the recommended bibliography as well as the UdL's resources, in particular, the library. In order to achieve this objective of the teaching methodology, a practice session related to obtaining and using bibliographic resources will be carried out.

Thirdly, committing to transversality not only requires students to acquire theoretical and practical knowledge, but also to attend conferences with high-level academic and civil society experts organized from the area of knowledge to complement their training. Therefore, attendance at conferences and seminars, which will be determined during the course, will be promoted.
