## Subject's extra information

Territorial planning aims to guide the location of the population, economic activities and physical infrastructures, while respecting the criteria of economic growth, social development and conservation of the environment. To do this is based on the knowledge, potentialities and specific constraints of each area. In this subject, this discipline will be addressed from the point of view of managing the effects that the tourism phenomenon can generate over space.

This teaching guide is intended to be developed with a group of 20 to 25 enrolled. If the number increases or decreases significantly, some of the activities and evaluation criteria may undergo modifications that will be discussed when the registration is closed and the final number of students is available.

## Methodology

The main methodological axes of the subject will be the following:

1. Level of general knowledge obtained in the field of processes and techniques of the planning of the territory. It will be evaluated after a final exam. It is a requirement to pass the subject to pass the final average 5 and at least the exam's score of 3'5.
2. Practical sorting work done during the course and presented in a timely manner as they are executed.
3. Assistance and use of the outings during the course.

Learning outcomes:

1. Capture the potential of the natural environment in local development
2. Know the unique framework of Catalan territorial planning (territorial plans)
3. Knowing the unique tourist enclave models and their environmental and social repercussion
4. Knowledge of the main theories on management and planning
5. Identification of the main legislative body related to urban planning
6. Practice of territorial diagnosis activities aimed at planning

7. Recognize in the territory the cultural heritage values worthy of protection and promotion

## Development plan

Theoretical classes: 36 hours (1 session per topic, except for topics 2 and 3 and 6, which will be done in two sessions).

Practices:

- Tutorial of group work: 2 hours
- Presentations: 4 hours
- Study outings and / or talks (dates to be specified): 10 hours

The timetables, as well as the exam calendar, will be published pertinently on the degree website. They can be consulted there.

The times and dates of the outings made with the students will be published on the virtual campus. It is the student's responsibility to periodically consult the virtual campus to find out about this and other information.

## Evaluation

Exam: 50% (there is recovery) (check the date and classroom on the degree website, where you will find it updated)

Practical work (no recovery):

- Work or works linked to study trips (20% of the grade)
- Assignments or practices on the course contents (30%)

All those who can not attend the course exits must submit an official justification of the reasons (work, medical, legal obligations ...). In this case, the final grade will be calculated without the corresponding exit. If no supporting document is delivered, it will be understood that the exit note is 0. Additionally, those students who do not follow the explanations, arrive late or carry out any activity that affects the good development of the exit can be penalized with 5 points, which will be deducted from the test note.

In the event that, due to force majeure, the planned activities cannot be carried out, the visits will be carried out virtually, with the means and format agreed at that time.

In case the students cannot attend the classes to be isolated, they will have at their disposal the material of the subject in the virtual campus so that they can follow the syllabus. Once recovered, it will be possible to establish, if it is the case, a tutorial session to review the most important concepts of the syllabus and to solve doubts.

**Alternative assessment** Alternative assessment: In the event that a student documentally proves that they are unable to attend scheduled activities in the continuous evaluation (for paid work, second or subsequent tuition of the subject ...), they can opt for a Unique test of validation of competences and knowledge that will be carried out on the day and in the schedule established in the calendar of evaluation of the Degree for the final test of the ordinary evaluation. This test will consist of an examination with contents expanded with some of the practices of the course. The application for this assessment modality must be carried out before October 15 with documentary accreditation and, once done, it can not be modified.

It is recalled that the total or partial plagiarism of any part of the course work, as well as any other fraudulent procedure carried out to carry out work activities, will entail the qualification of 0 (suspense) in the final qualification of The subject since it violates respect for intellectual property.
