Subject's extra information

Physiopathology is the basis of the professional development of the general physiotherapist to obtain the sufficient capacity that the permeti conèixer, describe basically, program and treat physiotherapy health problems. Also identify health problems, with the need for referral and consultation with high professionals. The objective of the subject is that the student will acquire the konwlegde of the most common nosological entities in medical-surgical pathology related to the physiotherapist's activity.

The course is during the first semester of the academic course. The material is made up of different blocks: neurology, rheumatology, traumatology, geriatrics, urology, pneumology, and basic vital suport.

The subject is focused from a theoretical-practical point of view. The classes are structured in 6 ECTS, in different groups: Lleida and Igualada (check the current calendar on the web).

2020-21 course, due COVID-19, the Faculty has decided that the teaching will be on-line, so the sessions will be in a synchronous videoconference format through the CV. These directives can be modified and updated by new regulations. Possible modifications will be informed in CV.

Learning objectives

- To know the pathophysiology of diseases, identifying the manifestations that appear throughout their process.
- Assess the functional state of the patient, considering the physical, psychological and social aspects
- To know, in general, the medical and surgical treatments of the diseases, fundamentally in their physiotherapy aspects.
- Know the surgical material
- To intervene in the acts of promotion, prevention and recovery of the health.

Methodology

The teaching methodology is aimed at the development of the student's learning through classes with the active participation of students, seminars, clinical cases and directed activities are also planned.

The classes will be supported with projections of iconography and computer presentations.

Attendance at lectures is strongly recommended.

The non-attendance activity is managed through the Virtual Campus (CV) of the UdL.
