#### **ORDINARY EVALUATION**

The evaluation is continuous. To pass the subject, a grade greater than 50 points must be obtained by adding all the evaluation activities shown in the table.

It is a mandatory requirement to pass each part of the A-1 assessment evidence. If this requirement is met, it will proceed with the summation of all the evaluation evidence that will result in the final score of the subject. If this requirement is not met, the summation of all the assessment evidence of the subject will not be made. Therefore, to pass the subject two conditions must be met: 1) pass the A-1n evaluation evidence and 2) that the sum of all the evaluation evidences give a value greater than or equal to 50 points (out of 100). In accordance with the assessment regulations, students can take the recovery test for all those tests that count for at least 30% of the grade or that have some requirement. Therefore, the only appraisal evidence recoverable is Exhibit A-1. If block 1 is not passed, but the weighted average of the other evidence gives it more than a 5, the grade that will appear in the minutes will be a 4.9, suspended, in accordance with the current assessment regulations. Students who want to increase their grade can present themselves for recovery, but renouncing the grade obtained previously.

No activity will be accepted outside the deadlines. Any activity outside the deadline will be recorded as not presented, with a numerical value of 0.

This subject is particularly sensitized against plagiarism. When plagiarism is detected from another colleague or from a bibliographic source exceeding 20% of the total of an assessment activity, this activity will have a rating of 0 in application of the current assessment regulations.
