Evaluation

EVALUATION SYSTEM

The evaluation of the training activities will be carried out using the following percentages:

Three partial theoretical Blocks of content of the three blocks of the multiple choice subject that will account for 75% of the grade (25+25+25). Each of the three partial Blocks will be done in person on paper and pencils. Each Blog is a test with 40 questions and consists of a booklet and an answer sheet. Both documents must be handed over to the teacher, who will staple them together. One document without the other cancels the test. The theoretical material to be assessed is derived from the content explained by the teacher in class, slides (given to the students) and the compulsory readings.

A fourth block of practices (25% of the grade) consisting of field work and data analysis from questionnaires or tests (15%) and the preparation of reports from personality tests (10%).

There is no minimum grade in any of the 4 blocks. The qualifications will be cumulative in a theoretical range of 0 to 100 points (25+25+25+25) and a total of 50% will be necessary to pass. The qualifications will go to a range of 0 to 10 and it will be approved with a 5.00.

The evaluation will be carried out in Catalan.

Students have the right to individual review of their test on the agreed day and time, upon request by email from the student himself. If the student cannot come to review and can justify it according to the teaching guide of the faculty, another day of review will be given. The reviews will only be carried out on the previously agreed and announced date.

The answers or marks in the written exams and papers will be kept digitized (data) and on paper during an academic year.

Handwritten and bound practical work TP-1 and TP-2 handed in will be kept for one year in the professor's office. However, it is convenient for the student to save the work electronically (eg in pdf) in case there is any problem or loss with the original manuscripts.

The practices will be face-to-face and require 80% assistance for its computation. Less attendance means a grade of "no show" and possible points assigned to practices will be lost. If it is detected that a student signs for another in the exams, or there is a signature without the student being in class, the entire practice will be graded as "not presented" and the assigned points will be lost.

The final grade is the sum of the evaluation of the content of the three theoretical blocks of the subject (75%), plus the practical block (25%).

Failure to carry out the content tests, non-participation (80% of practical attendance) or non-delivery of the programmed practical reports will mean the loss of the points that are computed.

Deadline days will be set to deliver the work in advance. After the deadline, if the work has not been delivered, it will be considered not presented with the loss of the points that compute, as well as the non-presentation in the theoretical exams.

Recovery tests will not be carried out as none of them exceed 30%.

As of the 2021/22 academic year, the qualification of "not presented" will be applied in all the subjects of the different degrees and master's degrees of the FEPTS provided that the student has carried out a percentage of less than 30% of the evaluation activities of the subject.

The first two tests of the partial theoretical blocks are carried out approximately on week 5 and 10. Being during class hours, it is possible that a classroom with a capacity for 150 students is not available, which is what is needed. If this were the case, the tests will be held in one of the two classrooms of the Multipurpose Building on the third floor or on the ground floor of the Faculty of Law from 2:00 p.m. to 3:00 p.m. (or another alternative that has capacity for at least 150 students). If so, the first day of the course will be reported so that the student can schedule it in advance. If a student works during these hours, the company is obliged to give permission for a university exam. A receipt signed by the teacher is provided. The third partial test will take place at the time and on the day set by the coordinator of the Degree in Psychology.

ALTERNATIVE ASSESSMENT

In exceptional cases that have the approval of the Study Committee of the center responsible for teaching the degree, the alternative assessment will consist of a theoretical test that includes the three blocks (12 topics) (75%) and face-to-face practices (25%). The time and length of the assessment will be similar to that used by continuous assessment face-to-face students.

As indicated in the Regulations for Assessment and Qualification of Teaching in the UdL Degrees and Masters in article 1.5 on alternative assessment, point 2, page 7: "If the nature of the subject requires it, it will be an essential requirement to have the single assessment option attendance at certain face-to-face activities (practices, rotations, field trips, seminars, etc.) on the established dates, activities that will have to be specified in the teaching guide, may not entail discrimination regarding continuous assessment in relation to with the maximum grade that can be obtained in that subject." Therefore, the practices will be mandatory and face-to-face for these students as well as those who do continuous assessment. Failure to carry out the practices supposes the loss of 25% of the final grade.

RECOMMENDATIONS

The Personality Psychology subject is closely related to other subjects in the curriculum such as Psychopathology, Differential Psychology, Statistics, Psychometrics, Psychological Assessment and Diagnosis, Structure and Functioning of the Nervous System, Biological Bases of Behavior and Basic Psychological Processes. Having taken or taking these subjects will provide a better understanding of the subject. It is

recommended that the student have basic notions of statistics.

STUDENT-TEACHER RELATIONS AND TUTORIALS

The students will elect a delegate who represents the students. Any proposal, suggestion or complaint that affects the entire class will be channeled through the delegate (not individually). For individual consultations that affect only one student, tutoring must be requested within the established hours. Students are encouraged to make use of the tutorials for queries related to the subject or personal situations. It is recalled that attendance at the days and times of exams and dates of delivery of work is mandatory. Only the exceptions established in the Teacher Evaluation Guide will be accepted to request evaluations outside the established and announced hours on the first day of class and on the subject's website (www.petra-udl.com).
