Entrepreneurship in mountain areas: Business Project Preparation (CANVAS method).

Difficulties of Business Management in mountain areas. Opportunities and job niches.

Alternative models (Time bank, food cooperatives, self-sufficiency, social agriculture, etc.)

## Development plan

Initial presentation of the planning and dynamization conditions of the mountain areas and the meaning and relationship of the whole agenda.

Master presentation of the contents of each topic by each specialist and introduction to work practices. They will have a deepening in the central aspects to which more attention is given and which give rise to practices outside the classroom.

Presentation of experiences and tasks by managers of different organizations and companies that intervene in mountain areas and that complete and give meaning to general theoretical information.

Special celebration of International Mountain Day around December 11, with visits and conferences on the reality of the mountain.

Synthesis and final summary of the different contents of the subject, in order to establish a link between the different topics and facilitate the completion of a learning notebook by the student.

Daily face-to-face tutoring during the development of the subject by the person in charge, from 15:30 to 16:00
