EVIDENCE 1:

Description of the evidence:

Proof written that it will realise of face-to-face form and that will request at the pupils the analysis, reflection and synthesis around the key contents of the matter. The proof will be the last day of class.

Score: 40%

Date: it will realise at the end of the three weeks of development of the subject. Students who do not exceed 50% of the grade and, after the corresponding feedback, will have the right to recover the evidence with an equivalent written test. The maximum grade of this recovery will be a 5. This test will be announced well in advance to the students.

EVIDENCE 2:

Description of the evidence:

Re-design of an interdisciplinary project. The work will present in writing and also will realise an oral synthesis. Will have to utilise the TIC for the realisation of the oral synthesis.

Score: 40%

Maximum Date of delivery: The work written will have to hand as a maximum date the last day of the subject at *sakai –will communicate this date at the onset of the subject. They will not accept works later of this date. The pupils that do not surpass the 50% of the note and, after the *feedback corresponding, will law to recover the evidence and at handing it the January 2023 and the maximum note will be a 5.

EVIDENCE 3:

Description of the evidence:

At each face-to-face session the teacher will pass a questionnaire to value the rank of realization and deepening of the readings. The students will realise of periodic form, during the three weeks at that it develops the subject, short proofs of content on the obligatory readings.
