Subject's extra information

The scope of study of this module will pay specific attention to the issue of women who are in a situation of vulnerability and, especially, women victims of gender violence. To this end, a phenomenological analysis of gender violence will be carried out, and attention will be paid to differential morbidity and the repercussions that its lack of consideration has on the diagnosis, care and healthcare of women, as well as on the effects on the physical and psychological health of gender violence.

Learning objectives

- Be able to identify situations of gender discrimination and violence and the factors that cause them.
- Know the differential morbidity and the influence of gender biases in the diagnosis and treatment of diseases in women
- Differentiate as structural violence to health care.
- Know the operation of the centers and services of attention and protection of victims of gender violence.
- Know the techniques of intervention with victims of gender violence and prevention models distinguishing the most appropriate.

1. Recorded sessions. The recorded sessions will serve to explain theoretical and methodological issues, to solve the difficulties that have been identified in the result of the activities set by the teacher.

2. Activities. On the basis of what was explained in the recorded sessions, of the documentation posted on the virtual platform and the readings compulsory, 3 tasks are established in all the tasks distributed among the subjects in which the contents of the subject are distributed. The documents of help will be posted in the Resources section of the virtual campus for your reference.

The subject of Women's Health and Gender Violence will be taught in the second semester and will be evaluated in the month of June.
