Subject's extra information

The figures of women who are in a relationship of violence are known. The most widespread effect by women is the gradual weakening of their own strengths, both cognitive, affective and health. In addition, most of the women in this relationship are dependent on children and therefore have the responsibility to be available for their care.

In this subject we will see the therapeutic intervention that is done when women who are in a relationship of violence reach the different services where they can attend.

Women are at very different times and in very different realities. And this is the great challenge of the professionals who receive them: to have the tools to reconvert the suffering they present in the strength they need.

Learning objectives

Provide tools and resources to:

- 1. Detect indicators and risk factors in gender violence.
- 2. Understand the process of violence and its effects on women in a comprehensive way.
- 3. Prevent abusive relationships.
- 4. Be aware of the difficulties that this kind of care entails for professionals involved.

- 3. How women come to ask for help: psychic and physical state.
- 4. How to care for women who arrive: listening, empathy and unconditionality.
- 5. Tools to understand and empower women who come to a psychological care service.
- 6. Reasons that women express to continue with a partner that hurts them.
- 7. Effects and affects of the professionals that attend to these types of problems.

Throughout the course different teaching methodologies will be followed so that the student can achieve the contents of the subject in the best possible way. As it is an online subject, necessarily, among pedagogical tools are online tutorials, reading and analysis of documents, etc.
