Learning objectives

After carrying out the PRACTICES, the students must have achieved the following results / objectives:

- will know some aspects of the situation of women in different social environments.
- will have acquired intervention strategies to improve equal opportunities and treatment
- will have acquired practical knowledge in the field of healthcare, public administration, management and organization of companies, etc.

Subject contents

Methodology

The methodology of this subject must necessarily be very diverse and wide, since the scope in which the practices can be developed is also. The methodology to be used will be specified according to each training project with the institution / organization / company that receives the student.

Development plan

In each case it will be determined by the training project. In any case, according to the allocation of ECTS credits that this subject has in the Master's Plan of Studies, it will involve the completion of 125 h. of effective practices by students.

Evaluation

At the end of the practices, both the students and the corresponding tutors must prepare a report evaluating the Practices, by virtue of which the student's activity will be evaluated and, where appropriate, the passing of the subject.
